The final budget statement for our March 2012 show is attached. We received a check from the Combined for \$297.90 last night at the meeting. Our total profit/loss statement is included on the attached document Budget March 2012. The HCS Budget March 2012 document is the statement from the Combined Specialty that details how they determined our show income/expense from Onofrio. After our judge expenses, insurance, trophies and AKC application fees were factored into this event we ended with a loss of (\$293.95) for the March show. The original projection was for a loss of about \$475. We did a great job of holding expenses to a minimum despite the low entries. Special thanks to all the club members who came to the show and helped to make it a success.

Notes from the 4/24/2012 Houston Combined Specialty Meeting

March 2012 Events -

No real issues raised for the March 2012 event. There were some complaints about the condition of the restrooms in the back of the facility. Those restrooms will be locked and inaccessible at the next show. There were also complaints about the mobile homes taking all the front parking places. This is likely not going to be addressed – or resolved.

The March 2012 Combined Specialty netted a profit of just over \$200 this year. There will likely be a raise in parking fees next year to keep the events from running in the red next year. Low entries, and increased costs were blamed for the poor income at these events.

July 2012

Everyone needs to remember – there will be NO DRIVE IN UNLOADING on Wednesday July 18th. All drive in unloading will be Tuesday July 17th from 1pm to 8pm.

Dear PATRICIA MIMS, Corresponding Secretary for Houston Dachshund Club, Inc.,

Communication between AKC and its affiliated clubs is crucial to the success of your club's business, planning/approving its events, and keeping each other informed of "breaking news" as well as legislative initiatives in the sport of purebred dogs. The fastest, most efficient and cost-saving way to accomplish this goal is to have up-to-date email addresses for club officers, especially the President and Corresponding Secretary, as well as all club members for larger outreach on important issues to purebred dog owners.

So far, more than 1,000 AKC clubs are enjoying the ease of submitting their annual membership lists (as required in the Rules) by using the electronic submission forms on AKC's website.

After January 1, 2013, a fee will be initiated for the processing of membership lists which shall be waived if the membership list is transmitted electronically.

As you know, your club's membership list will only be used by AKC to conduct AKC business relating to events, club relations, legislation, and other outreach by AKC to its affiliated club members. The names and email addresses on the list will not be provided to government agencies or sold to third parties. After electronic submission of the club's membership list, all club officers of your club will receive an email from the AKC confirming the submission of the list.

Clubs can submit their membership information by uploading either a Microsoft Excel or CSV formatted file from the Club Membership Lists page here or navigating to http://www.akc.org/club_membership/ and using the access code provided below.

Also, at any time updated officer lists including complete contact information (name, address, phone number, and email address) can be sent to event-ops@akc.org.

In preparation of this move to electronic submission of membership lists, we are asking that all the clubs which have not already done so within the last twelve (12) months to submit an electronic membership list by April 30, 2012. If a club finds that it is unable to submit an electronic membership list, please contact us so that we can render the assistance necessary.

Protect Yourself and Your Club:


- Obtain sufficient insurance coverage. Many insurance carriers also provide bonding
 for Club Treasurers. Most venues holding events require proof of liability insurance. If


Prepare & Prevent:

- Use an official AKC show entry form for all applicable competitions and/or AKC sanctioned events. http://www.akc.org/pdfs/masterform.cfm. This is required* for many competitions. The form contains the liability waivers and certification that the dog entered is not a hazard. The form must be signed and the club should retain the entry.
- Incorporate a liability waiver within any entry or application form for club functions (especially ones with public access) and require participants to sign the waiver.
 Parents or guardians should sign for minor children.
- Prominently display the liability waiver at your event.

*Ch. 1 Sec. 2 of Match Regulations states: All of the Rules Applying to Dog Shows, and the Agility, Tracking and Obedience/Rally Regulations will apply to sanctioned matches, except those which specifically make reference to license and member events and except where otherwise stated in these Regulations. *Ch.11 Sec. 4 of Rules Applying to Dog Shows states: To be acceptable, an entry must be submitted with required entry fee and be on an Official American Kennel Club entry form.

The purpose of Meet the Breed is to present good quality specimens to the public, to educate their eye, help a family avoid making the "wrong" breed purchase, and to introduce the public to a few of the responsible members of the fancy to offset some of the negative press out there. Once again, we have made no changes to our guidelines.

First the "No" list:

No sale of puppies in the MTB ring.

No preliminary discussion/negotiations of stud dog service.

No discussion of dogs available for rescue placements in the MTB ring.

Bitches in season are not allowed in the MTB ring.

No personal business cards or personal contact information may be given out.



Now the "Yes" list:

All sorts of breed information is encouraged.

Club information, including meeting dates, location and times, breeder referral, membership list, rescue contacts, training contacts, etc. is encouraged.

We also encourage parent club contact information including rescue contacts and breeder referral contacts.

Young dogs may be changed out or removed if they become tired.

A copy of our guidelines is attached in case you need to review them or in case you want to hand them out to your presenters.

If you want to participate this year, please complete and return the form below. We will be back in touch with you AFTER THE JUDGING SCHEDULE COMES OUT with your scheduled time.

As always, the person who contacts us will be considered our primary contact for your breed.

This will be the person we contact for scheduling. This will also be the person was contact if we see a problem

If your club wants to participate but the primary contact MAY CHANGE, THAT'S FINE. Just let us know and we can work with you.

AKC will be accepting a spreadsheet from us which lists the club(s) to be credited with the participation; however, if you want one, we will also be emailing a participation letter to you following the show.

For that reason, we really need the correct name of the club to help AKC make accurate notes and postings.

If there is a particular email address where the letter should be sent, we will, of course, need to know that, too.



Dear Houston Area Specialty Clubs:

The 2012 "Aloha Baytown" weekend shows were a huge success. Placing two rings on the concrete patio in the front of the Crosby Fairgrounds, and expertly packing the dirt surface in the arena made a huge impact on the shows. Exhibitors and judges loved the casual atmosphere, the Hawaiian shirts, and breezy weather. We have great news for 2013. The Baytown KC dates will now be Friday (obedience & rally trials) April 26, and All Breed Dog Shows with obedience and rally trials on Saturday and Sunday, April 27 and April 28, 2013 at the Crosby Fairgrounds.

Since the Fairgrounds are set up and ready by 1:00 PM on Friday, we would like for you to join us by holding an Independent Specialty Show on Friday afternoon or evening. There would be no charge for using the ring equipment or facility. Onofrio Dog Shows offers a "package deal" for specialties, which makes it very affordable for clubs. We have had clubs do this in the past, and we would be glad to explain it to your club. Or your club could have its own show secretary, if you prefer.

If your club already holds a specialty at another time of the year, we would like to invite you to hold a "Sweepstakes" on Saturday and/or Sunday, as part of the all breed show. (Specialty clubs are allowed to hold up to eight sweepstakes events each year.) Sweepstakes are a good way to increase the entry in your breed, and hopefully create majors. The BKC would absorb all the costs associated with holding a sweepstakes. We would help you complete all the necessary applications to hold such an event. Just contact us.

Your club could also hold an <u>Independent Specialty Show (limit of 50 dogs)</u> after Best in Show on <u>Saturday</u>. Several clubs did this when our shows were held at Ford Park in Beaumont. Each club was able to get majors at their specialty, and also at the all breed shows. This could mean three (3) majors in one weekend.

The BKC is planning to continue the "Aloha Baytown" theme in 2013. By moving the shows to Saturday and Sunday, instead of Friday and Saturday, we anticipate having a much larger entry. We will also continue to have interesting vendors, a great food concession, and the exciting raffles each day.

For those that are not aware, the US Department of Defense has funded a large spinal cord injury study for dogs with disk herniation at Texas A&M University. The study is a wonderful opportunity for clients/dogs to help military personnel with nijuries and offers significant benefits for participating clients. The first part of this study will be open Monday June 18th and essentially provides imaging, surgical treatment, rehab, medications, hospitalization for 7 days, and recheck for a fixed price of \$3000. This part of the study is examining urinary voiding parameters in dogs with surgical thoracolumbar disk injuries. FYI, here is a brief summary of the study:

Inclusion Criteria:

- T3-L3 spinal cord injury
- Male or male castrated
- 5-15 kg
- 24 hour or less duration
- Only non-ambulatory paraplegic or paraparetic dogs with intact nociception. Deep pain negative dogs cannot enroll.
- Surgical treatment

Study Procedures

- Sedated urinary studies prior to an esthesia for work-up, 3 days post op, 7 days post op, and 42 day re-check
- No alpha blocking agents, skeletal muscle relaxants, or muscarinic agonists can be used during hospitalization. Examples of such drugs include prazosin, phenoxybenzamine, diazepam, and bethanecol.

Financial incentive

- Free re-check and fixed price \$3000 work-up, surgery, and rehab


